1. Do you support the efforts of Welcoming Michigan? Why? Why Not?

ANSWER: I do not support Welcoming Michigan. Welcoming Michigan is a project of the Michigan Immigrant Rights Center in Kalamazoo, and affiliates with Welcoming America, a left wing group that does not advocate for our border protections, nor do they support the rule of law and our constitution. Their ultimate goal is to increase governmental spending on social programs and would increase the refugee resettlement numbers in Michigan.

2. Do you support the current U.S. Refugee Resettlement Program? Why? Why Not?

ANSWER: I do not support the US RRP. As a soldier in the US Army, I saw this program close up, and saw how dysfunctional it is. Most individuals that are labeled as Refugees, do not even qualify under the proper international treaty definition of refugees. Furthermore, this program is bringing people to this nation that are changing our nation and its values, and live off of the benefits provided by the government. Instead, a more compassionate answer to the RRP is to allow the individuals that call themselves refugees, to rebuild their own homeland.

3. Do you support making Michigan a Sanctuary State? Why? Why Not?

ANSWER: I do not support making Michigan a Sanctuary State. Not only do I not support such an action, but any action to create any type of sanctuary is illegal, and would break our national immigration laws.
