1. **Health Care Access and Refugees with Special Needs:** Refugees have convenient access to medical, dental and mental health services in Dearborn through a variety of health care providers. USCRI Dearborn is able to serve refugees with special physical and mental health needs or disabilities through its partnership with the ACCESS Community Health Center. In addition, USCRI Dearborn manages a Preventative Health Program with the Michigan Department of Human Services, which has been able to provide and assist with health follow-up services for all refugees in the local area, including those served by other

resettlement agencies. There are no conditions or special needs that the agency is unable to accommodate.

2. **Public Outreach:** USCRI Dearborn is a strong advocate for refugees and immigrants in the Detroit community. The agency Director is a member of the State of Michigan Refugee Advisory Council, the Michigan Committee for Refugee Resettlement, and the city of Detroit's Immigration Task Force, participating in the Re-Population Committee. During FY2015, the Director also participated in consultation meetings with the City of Detroit Council Members, Macomb County Board of Commissioners, Welfare District and Office Managers, business owners, employers, and landlords to discuss and resolve key issues. These enhanced meetings and discussions have contributed to positive outcomes for refugees including resolution No. 293 of the Board of Commissioners of Macomb County, urging Macomb County community leaders to engage and support the county's refugee and immigrant populations and take action on issues that impact the refugee and immigrant community. The broader community is very supportive of refugee resettlement in the Detroit area. USCRI Dearborn management and staff will continue to engage the local community during FY2016, building further support and partnerships.

3. **Financial Resources:** USCRI Dearborn receives funding from private individuals, religious institutions, and corporations that supplement and support the R&P program. In addition, the office receives funding from the Nissan Foundation. USCRI Dearborn is able to utilize these contributions to meet emergency or critical needs of refugee clients.
