1. **Health Care Access and Refugees with Special Needs:** The only condition that St. Vincent Catholic Charities is *unable* to accommodate is severe mental illness. It is extremely difficult for refugees to access psychiatrists in the Lansing area as there is a long waiting list for any

psychiatrist who takes Medicaid. Other characteristics may be challenging (singles, persons with disabilities, etc.) but they can be accommodated.

2. **Public Outreach:** STVCC conducts outreach sessions for a variety of organizations, agencies, businesses and community groups on a monthly basis, with internal goals of conducting at least one new outreach session per month. These sessions provide basic definitions and explanations of the refugee program as well as benefits of refugees on the community. The outreach activities have resulted in increase in awareness and acceptance of refugees and have helped to maintain a steady flow of cash and in-kind donations and volunteers. The annual 5K Fun Run, along with “Spring into Giving” and Christmas Giving Trees, increases donations of furniture and household goods.

In 2016, STVCC will continue to prioritize outreach presentations with a special emphasis on support for Syrians. STVCC is working with a local Syrian surgeon who has started a new non-profit to help Syrian refugees – the Foundation for Peace and Development. This organization will work specifically with Syrians to access healthcare, education and jobs. In addition, STVCC has joined the City Council Ad Hoc Committee on Diversity and will use that forum to access more connections and resources for new arrivals. STVCC is also planning to implement a refugee open house event in which members of the community can walk through the refugee experience from persecution to arrival in Lansing. Finally, STVCC is increasing its presence on Facebook and has created a regular schedule of posts to further engage the community.
